Our impact

Accurate measurement of our environmental impacts has enabled us to implement targeted and effective reduction efforts.

We began our sustainability journey by implementing our environmental policy and a waste management plan. These foundational documents provided the roadmap for our sustainable practices and set the standards for our operations. Next, we embarked on the task of understanding our environmental impact.

By calculating our carbon footprint and meticulously recording and monitoring our consumption of key resources such as energy, water, and paper, we have gained a clear picture of where we stand.















Armed with this knowledge, we have set ambitious yet achievable reduction targets. To help us meet these targets, we have introduced numerous initiatives aimed at reducing our resource consumption.

From encouraging members to switch to digital communications, to introducing office-wide recycling bins, we are continually seeking ways to lessen our environmental impact. Our efforts are not confined to just one person or team.

We have seen the power of education and awareness in driving sustainable change. That's why we have made efforts to keep our whole team, and our members, informed about our environmental initiatives and progress.

Through regular updates, we aim to foster a culture of sustainability within our organisation. One where each of our colleagues and members feel empowered to contribute to our collective sustainability goals.

Many small actions lead to big impacts

Our commitment to environmental sustainability is reflected in the practical steps we have taken to minimise our environmental impact.

We have focused our efforts on four key areas:

- · Reducing our carbon footprint
- Managing waste effectively
- Conserving energy
- Reducing water consumption.



While we are proud of our achievements, we know that there is always room for improvement and are committed to continuing our sustainability journey.



Reducing our carbon footprint has been a priority for us. We have achieved this by investing in renewable energy sources for our offices, promoting remote work, and many other changes. Our sustainable travel plan encourages car sharing and the use of public transport wherever possible. Through these measures, we have managed to significantly reduce our emissions.



Waste management initiatives are aimed at reducing the waste generated by our operations and ensuring responsible disposal. We have introduced recycling programs in our office, and purchase supplies made from recycled materials whenever possible. Furthermore, we have eliminated single-use plastics from our premises and encourage our members to do the same.



Energy conservation is key, and what we do use is from a 100% renewable source. We have implemented energy-saving measures such as installing LED lights, encouraging everyone to turn off equipment when not in use, and optimising heating and cooling systems. We also purchase energy-efficient appliances and electronic equipment for our offices.



Water conservation is an often-overlooked aspect of environmental sustainability, but one we take very seriously. We have installed water-efficient fixtures in our offices and encourage our staff to use water responsibly.

Controlling our carbon footprint

One of the most significant metrics in assessing our sustainability efforts is our carbon footprint.

Measuring our carbon emissions allows us to quantify our environmental impact, and establish clear targets for reduction.

Between 2019 and 2021, we saw a significant reduction in our total carbon emissions. In 2019, our total carbon emissions stood at 60.43 tC02e. This decreased by 47% in 2020 to 31.67 tC02e, and by 2021, we had achieved a further decrease to 28.02 tC02e, representing a 53% reduction from our 2019 levels.

Since 2019 we have reduced our Scope 1 & 2 emissions by 11 tonnes of C02e - that's the equivalent of 323,529 cups of tea!



In 2022, our total emissions increased to 93.81 tCO2e. It's crucial to note that this rise doesn't reflect a reversal of our sustainability efforts. Rather, it's due to the inclusion of new factors in our carbon footprint calculation, particularly the impacts associated with home working as our teams adapted following the global pandemic.

If we consider only Scope 1 and Scope 2 emissions (which excludes the impact of homeworking), our carbon footprint has continued to decrease consistently. From 28.89 tCO2e in 2019, we reduced these emissions to 25.00 tCO2e in 2020, 21.95 tCO2e in 2021, and further down to 17.91 tCO2e in 2022. This data illustrates the effectiveness of our strategies in reducing our direct and energy-indirect carbon emissions.

Our efforts in reducing our carbon footprint are yielding significant results, but we're still continuously striving to improve. While the addition of new factors such as homeworking has increased our measured total carbon emissions, we're committed to including more of our value chain and Scope 3 emissions, so that we can take full accountability for our impact. We'll work towards innovative solutions to reduce these emissions, and continue our progress towards true sustainability.

Our social impact

We firmly believe that our impact extends beyond our commitment to environmental sustainability. Our dedication to creating positive change encompasses the well-being of veterinary professionals, the broader community, and the animals our members care for.

The heart of the VDS lies within its stakeholders: our members, employees, and the wider veterinary community. By recognising the essential role that each individual plays, we're trying to create a work environment that is not just functional, but also supportive, inclusive, and empowering.

Veterinary professionals are the backbone of our Society, both as employees and members, and we deeply value their contributions. The well-being of our employees directly translates to the quality of care and services we provide.

As part of our 150th anniversary in 2015, we donated £150,000 to Vetlife, and an additional €20,000 to the IVBF. Since then, we have donated over £700,000 split between these two organisations, whose absolutely vital work we support wholeheartedly.



Our commitment to equity, diversity and inclusion remains steadfast. We believe that a diverse and inclusive workforce is crucial to driving innovation and promoting a sense of belonging. To this end, we have implemented policies that promote equal opportunities, irrespective of race, gender, age, or background.

Recognising the impact of our actions on the wider community, we've launched several initiatives. These include supporting all of our colleagues with the opportunity to take an annual volunteering day, at a charity of their choice.

This year our teams have worked on various projects. Our whole company got involved to "Go the extra mile" for Ukraine and Great Ormond Street Hospital. They have also engaged in tree planting and conservation in urban areas, and have supported local wildlife efforts.

As part of our sustainability commitments, we will continue to monitor, review and take proactive measures to further reduce our environmental impact.

We plan to invest further in renewable energy sources and explore more opportunities to balance our carbon. We're also working to refine our travel plan, to promote sustainable commuting options for our employees.

Our carbon reduction targets for the next five years are being set, reflecting our commitment to continuous improvement.
